The primary suite features a beautiful ensuite bathroom as well as both a walk-in closet and an additional standard closet. Practical updates and peace of mind come with a new roof (June 2025) with architectural shingles, Andersen windows, 200-amp electrical service, brand-new hardwired smoke/CO detectors with battery backup, and sump pump battery backups (2025). The home is also equipped with a reverse osmosis system servicing the kitchen and main level bathrooms, a water softener, and a septic system pumped and inspected in 2022 with no issues reported. Step outside to enjoy incredible outdoor living spaces: a brick paver patio with firepit, gazebo, and a sprawling backyard-perfect for gatherings or quiet nights under the stars. Vehicle enthusiasts will love the garage space, with an



attached oversized 2.5-car garage plus a detached garage of approximately 1,000 sq. ft. A new asphalt driveway (2022) adds to the appeal.
